

Kidd Valley “What’s Your Fave” Burger Contest Rules

OFFICIAL RULES - NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW OR REGULATION. PARTICIPANTS MUST BE WA STATE RESIDENTS 18 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY.

The information you provide will only be used in accordance with Kidd Valley Restaurants Official Kidd Valley “What’s Your Fave” Burger Contest Rules.

1. HOW TO ENTER.

Electronically through www.facebook.com/KiddValley: Facebook: During the Contest Period, enter through the Kidd Valley Restaurant’s application on the Facebook Platform (the “Application”). You may access the Application via the Kidd Valley Restaurant’s page on Facebook at www.facebook.com/KiddValley by clicking on the tab/link to the “Contest” page. You can then enter the Contest through the application on the Contest page. You must complete the entry form with all required information which will include your full name, email and/or telephone number on the entry submission page.

Limit: One (1) entry per person only.

Entries made by any other individual or any entity, including but not limited to commercial Contest subscription notification and/or entering services, will be declared invalid and disqualified for this Contest. Tampering with the entry process or the operation of the Contest is prohibited and any entries deemed by Sponsor, in its sole discretion, to have been submitted in this manner will be void. Sponsor’s computer will be the official timekeeper for all matters related to this Contest. Entries generated by a script, macro, or other automated means will be disqualified. Entries that are incomplete, garbled, corrupted, or unintelligible for any reason, including, but not limited to, computer or network malfunction or congestion, are void and will not be accepted. In case of a dispute over the identity of an entrant, the authorized account holder of the email address used to enter will be deemed to be the entrant. “Authorized account holder” is defined as the person who is assigned to an email address by an Internet Access Provider, online service provider or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address.

Kidd Valley Restaurants reserves the right to extend the contest based upon availability of product. Limit one (1) entry per person only. No mechanically or electronically reproduced entries will be accepted. Only one entry per person is allowed. Kidd Valley Restaurants and any of its affiliates, directors, officers, professional advisors, employees and agencies will not be responsible for: (a) any late, lost, misrouted, garbled or distorted or damaged transmissions or entries; (b) telephone, electronic, hardware, software, network, Internet, or other computer or communications-related malfunctions or failures; (c) any Contest disruptions, injuries, losses or damages caused by events beyond the control of Kidd Valley Restaurants; or (d) any printing or typographical errors in these Official Contest Rules or any other materials associated with the Contest. Any questions regarding the number of entries submitted shall be resolved by Kidd Valley Restaurants at its sole, reasonable discretion. Contest prize drawing winners will be determined from all eligible entries on or near June 1, 2017. Winners need not be present for selection.

2. ELIGIBILITY. This Contest is open to all legal Washington State residents only who are eighteen (18) years of age or older at the time of entry. Employees, officers, and directors of Sponsor, Administrator, and each of their affiliated companies, subsidiaries, licensees, franchisees, distributors, dealers, sales representatives, their advertising or public relations agencies, and any and all other companies associated with the Contest (collectively, the “Contest Entities”), and each of their immediate family members and/or people living in the same household are not eligible to participate. All eligibility is subject to all federal, state, and local laws and regulations. All entries submitted are the property of the Sponsor.

If the Contest is terminated prior to the stated "Deadline", Kidd Valley Restaurants reserves the right to award prizes based on the entries existing before the termination date. Decisions of Kidd Valley Restaurants are final on all matters relating to this Contest.
