

Kidd Valley Burger Fan Trivia Contest Rules

1. HOW TO ENTER.

Store: Enter directly by visiting Kidd Valley on Pier 54 (1001 Alaskan Way, Ste 104, Seattle, WA 98104). Look for entry box and complete form.

Online: To enter the Sweepstakes, visit KiddValley.com, access the trivia contest page and fill out the form in its entirety to receive one entry. Or visit Kidd Valley's Facebook page (www.facebook.com/KiddValley.com) and proceed to the "Trivia Contest" tab.

Limit: One (1) entry per person only.

Entries made by any other individual or any entity, including but not limited to commercial Contest subscription notification and/or entering services, will be declared invalid and disqualified for this Contest. Tampering with the entry process or the operation of the Contest is prohibited and any entries deemed by Sponsor, in its sole discretion, to have been submitted in this manner will be void. Sponsor's computer will be the official timekeeper for all matters related to this Contest. Entries generated by a script, macro, or other automated means will be disqualified. Entries that are incomplete, garbled, corrupted, or unintelligible for any reason, including, but not limited to, computer or network malfunction or congestion, are void and will not be accepted. In case of a dispute over the identity of an entrant, the authorized account holder of the email address used to enter will be deemed to be the entrant. No mechanically or electronically reproduced entries will be accepted.
